

Editorial

Another season of competitive bridge is off to a reasonably smooth start, entries for the early season events are much the same as last year and as yet, no disaster has struck. Beneath the surface, however, there are areas which give cause for concern.

First, is the continuing failure of Welsh Bridge to attract young players into the game . A year ago the previous Editor of this Newsletter appealed to those members of the W.B.U. who have contact with schools and colleges to make a real effort to encourage and promote the formation of Bridge Clubs in those institutions; this seems an appropriate time to repeat the appeal. At present Wales has a worse record at this level than most other European countries – our future Camrose success depends on rectifying this.

A very worrying aspect of Welsh bridge is the lack of awareness of the basic laws and ethics of the game. Even at the highest levels , players seem unaware of their basic duties and rights. For some years the W.B.U. has followed the E.B.U. code of Laws and Ethics, but whereas E.B.U members receive a booklet each year which informs and reminds them of the code, W.B.U. members are largely left to find out the rules for themselves. There needs to be a real drive by Clubs to increase the understanding of their members in these important areas. Future editions of this Newsletter will include items dealing with difficult interpretations of the Laws. Members are invited to send in details of situations where they have found difficulty in obtaining or understanding a ruling.

Tournament Organiser's Report

- My telephone number has now changed to 758021. The code has also changed to 0554.
- 2. Would anyone who would like a copy of a poster advertising Welsh events run solely for under-21 and schoolchildren, please contact me. I would be grateful if Secondary School teachers would take one for display at their school. Also university students returning to college.
- 3. The draw for the principal Team events has now been made, with the Cambria Cup now zoned for the first round. I would be grateful if team captains would make every effort to complete matches before the given dates.
- 4. This year's Mens and Ladies National Pairs Finals will consist of 7 tables as opposed to 8 tables in previous years. The National Mixed Pairs Final has been increased from 11 tables to 14.

Selectors' Report

1. CAMROSE TRIAL The first trial, held at Raglan on 22nd / 23rd of September, consisted of 4 tables. The results were calculated using victory pointed datum scoring. As a result of the trial the following pairs have been invited to the final trial at Raglan on October 13th / 14th: P.D.Jourdain + R.G.Upton, G.Evans + A.Thomas, Mrs J.Newton + Miss J.R.Newton, Mrs J.Casey + Mrs M.Pierce, M.Hirst + G.Holman, A.Casey + A.Pierce

The pairs finishing first and second in this trial will be quaranteed selection for one match during the current season.

2. LADY MILNE and JUNIOR CAMROSE Pairs wishing to be considered for this year's trials are reminded that they should submit their names to an Area Selector by the closing dates given below.

GENERAL NEWS

Elsewhere in this newsletter you will find details of this season's Camrose trials. The scoring system used in these trials is described as "victory pointed datum scoring". This phrase must be virtually meaningless to the vast majority of players in Wales and even to those who have experienced it, the method is a source of much confusion and misconception. Since this type of scoring is becoming increasingly common in trials etc., it is perhaps appropriate to give a brief explanation.

1. Each board is played at every table in the trial.

2. The I.M.P. score for a NS pair is found by comparing their score on the board with the score at each other table in turn and using the normal I.M.P. scale (in effect each EW pair playing the board is treated as team—mates of the NS pair). These I.M.P.s are totalled. The process is reversed for EW pairs.

3. The boards played against one pair are regarded as an individual match and the IMPs for these boards are totalled.

4. The IMP total for each match is converted to Victory Points using a scale chosen to fit the particular event. e.g. if six boards are played against each pair and the board is played at four other tables, then the match can be regarded as twenty four boards.

This method of scoring can produce some frighteningly large scores on individual boards, particularly if there are five or six tables in the trial, but fears that one board might have an undue influence on the overall result do not seem to be borne out in practice. The method does meet a real need in trial situations where the performance of pairs must be considered, but the selectors are concerned with potential performance in team situations.
