

Welsh Bridge Union Safeguarding Policy July 2024

The purpose of this policy statement is:

- to protect children and young people, the elderly and other potentially vulnerable people who receive the Welsh Bridge Union's services from harm.
- to provide organisers and volunteers, as well as children and young people and their families, with the overarching principles that guide our approach to child protection.

This policy applies to anyone volunteering on behalf of the Welsh Bridge Union, including its Officers, Council and Management Committee, organisers, volunteers, sessional workers, agency staff and students.

Key Rules

At any event where children under 16 years old are present ("**Youths**"), they shall only be permitted to attend in the company or their parent, guardian or carer.

Where the Welsh Bridge Union is organizing the session where Youths will be attending, there shall be a nominated organizer on behalf of the Welsh Bridge Union (the "**Leader**") with either professional experience of supervising Youths (eg a retired teacher) and/or current DBS clearance. All the volunteers at the event shall work under the direct supervision of the Leader.

The Leader shall be responsible for:

- dealing with disclosures and concerns about a child or young person
- managing allegations against staff and volunteers
- recording concerns and information sharing
- child protection records retention and storage
- code of conduct for staff and volunteers
- behaviour codes for children and young people
- photography and sharing images guidance
- online safety
- anti-bullying
- managing complaints
- whistleblowing
- health and safety
- induction, training, supervision and support
- adult to child supervision ratios

We believe that:

- children and young people should never experience abuse of any kind
- we have a responsibility to promote the welfare of all children and young people, to keep them safe and to practise in a way that protects them.

We recognise that:

- the welfare of children is paramount in all the work we do and in all the
- decisions we take

- working in partnership with children, young people, their parents, carers and
- other agencies is essential in promoting young people's welfare
- all children, regardless of age, disability, gender reassignment, race, religion or belief, sex, or sexual orientation have an equal right to protection from all types of harm or abuse
- some children are additionally vulnerable because of the impact of previous
- experiences, their level of dependency, communication needs or other issues
- extra safeguards may be needed to keep children who are additionally vulnerable safe from abuse.

We will seek to keep children and young people safe by:

- valuing, listening to and respecting them
- adopting child protection and safeguarding best practice through our policies, procedures and code of conduct for staff and volunteers
- developing and implementing an effective online safety policy and related procedures
- providing effective management for organisers and volunteers through supervision, support, training and quality assurance measures so that all staff and volunteers know about and follow our policies, procedures and behaviour codes confidently and competently
- recruiting and selecting organisers and volunteers safely, ensuring all necessary checks are made
- recording and storing and using information professionally and securely, in line with data protection legislation and guidance
- sharing information about safeguarding and good practice with children and their families via leaflets, posters, group work and one-to-one discussions
- making sure that children, young people and their families know where to go for help if they have a concern
- using our safeguarding and child protection procedures to share concerns and relevant information with agencies who need to know, and involving children, young people, parents, families and carers appropriately
- using our procedures to manage any allegations against organisers and volunteers appropriately
- creating and maintaining an anti-bullying environment and ensuring that we have a policy and procedure to help us deal effectively with any bullying that does arise
- ensuring that we have effective complaints and whistleblowing measures in place
- ensuring that we provide a safe physical environment for our children, young

- people, organisers and volunteers, by applying health and safety measures in accordance with the law and regulatory guidance
- building a safeguarding culture where organisers and volunteers, children, young people and their families, treat each other with respect and are comfortable about sharing concerns.
